OUR INITIATIVE SUSTAINS THE NUTRITION PROGRAM FOR 315 CHILDREN AT LOS COCOS SCHOOL IN GRANADA AND THE 1400 STUDENTS AT ENRIQUE DEL OSSO SCHOOL IN REPARTO SCHICK, A POOR BARRIO IN MANAGUA. ADDITIONALLY WE ARE INVOLVED WITH SAGRADO CORAZON, A K-11 SCHOOL FOR 1200 STUDENTS AND HOGAR ALEGRIA, AN ORPHANAGE FOR 35 GIRLS IN GRANADA. LASTLY WE SUPPORT 19 HIGH SCHOOL AND COLLEGE STUDENTS IN LEON THROUGH A SCHOLARSHIP PROGRAM WHICH ENABLES THEM TO FURTHER THEIR EDUCATION. WE ARE PROUD TO SAY THAT WE HAVE A NUMBER OF UNIVERSITY GRADUATES.
